APPLICATION OF PRICES

1. Inclining block tariffs

Where multiple customers are being serviced by a single meter, the consumption tiers will be applied on a pro-rata basis.

2. Miscellaneous fees and charges

20mm water connection (dry) – standard house connection fee where a **Westernport Water** connection point exists.

20mm water connection (wet) – standard house connection fee where there is no **Westernport Water** connection point. Plumber to supply additional fittings.

Wastewater connection (standard residential) – standard residential sewer connection. Includes a copy of a property plan showing where the sewer connection point is located, Plumbing Industry Commission (PIC) authorisation number and an as constructed drawing.

Wastewater connection (standard commercial) – standard commercial sewer connection. Includes a copy of a property plan showing where the sewer connection point is located, Plumbing Industry Commission (PIC) authorisation number(s) and an As Constructed Drawing.

Information statement (standard) – statement of outstanding charges against a property. Is provided to the customer within 5 business days of request.

Information statement (priority) – statement of outstanding charges against a property. Is provided to the customer within 24 business hours of request.

Special meter read – special meter reading conducted by **Westernport Water** outside of normal meter reading cycle and at the specific request of a customer.
