All program participants should make note of VEU Registry and VEEC creation form changes from 10 December.

Regulatory changes commencing in December 2018

The Victorian Energy Efficiency Target Regulations 2018 commences operation next Monday, 10 December 2018.

The updated Victorian Energy Efficiency Target (Project-Based Activities) Regulations 2017 which introduces benchmark rating as a new project-based activities (PBA) method commences operation next Tuesday, 11 December 2018.

As previously advised, there will be a number of IT systems related changes which will be implemented to support these regulatory changes.

VEU Registry outage and changes

To prepare for this change, the VEU Registry (www.veu-registry.vic.gov.au) will not be available on Sunday, 9th December from 1pm to 6pm.

Updated systems which:-

 facilitate our administration of the 2018 VEET Regulations (including VEEC creation claims and product applications) will be available via the VEU Registry from Monday, 10th December.





 facilitate our administration of the benchmark rating method under the updated PBA Regulations will be available via the VEU Registry from Tuesday, 11th December.

All registers and calculators will still be available from the VEU Registry.

With the introduction of the 2018 VEET Regulations, we have made changes to all the activity names and product names in the VEU Registry.

VEEC creation form changes

Following the introduction of the 2018 VEET Regulations, we have updated some of the activity's VEEC creation forms and have created new VEEC creation form for some activities.

For activities with new creation forms, when using the upload form feature, you must select the:

- (08) version of the schedule (e.g. 34 Non J6(08)) when claiming for activities undertaken prior to 10 December 2018
- (18) version of the schedule (e.g. 34 Non J6(18)) when claiming for activities undertaken from 10 December 2018

Please note that we have made some changes to the lighting control device (LCD) field names in the VEEC creation upload forms for the lighting upgrade activities (activities 27, 34 and 35) further to release of the draft forms in November. You should check the upload forms for these activities on Monday, 10 December for detail of these field changes.
