

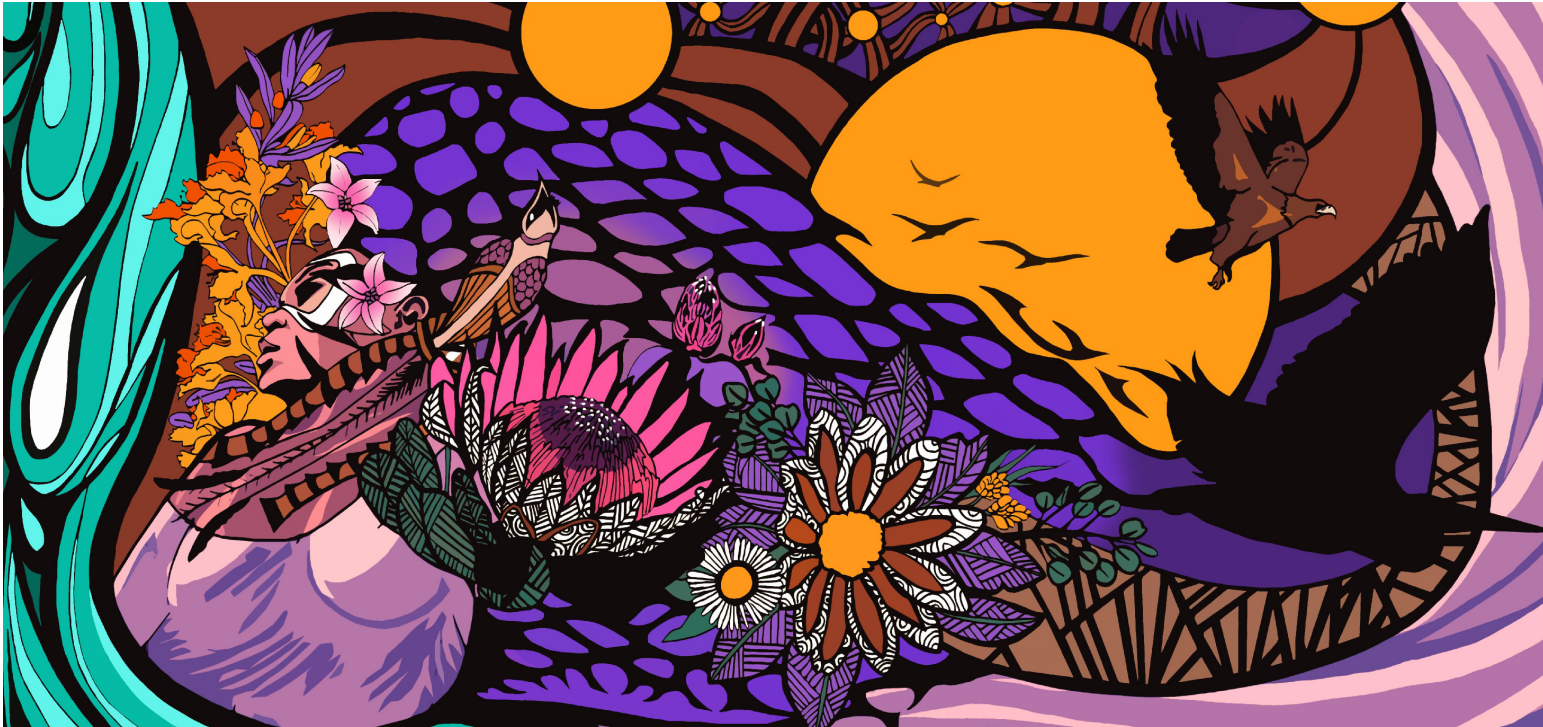

Review of VEU Fees – 2023

- Earlier in 2023, the Victorian Government consulted on a proposal to change fees associated with the VEU Program. The outcomes were communicated to all VEU program stakeholders in May 2023.
- In line with the Victorian Government's cost recovery policy, fees were adjusted across the program to better reflect the cost of operating the VEU program. Some commenced on 1 July, others commence on 1 November.

Changes to VEU Fees

Changes to existing fees payable by Accredited Providers

| Service | Existing fees (\$) | New fees (\$) | Commencement |
|--|-------------------------------------|------------------------------------|-----------------|
| Application for registration of a certificate (cost per certificate) | \$1/ certificate (for registration) | \$2.33/ certificate (for creation) | 1 November 2023 |
| Application for accreditation | \$500 | \$3,000 | 1 July 2023 |

New fees payable by Accredited Providers

| Service | Fee (\$) | Commencement |
|---|----------|-----------------|
| Application for renewal of accreditation | \$1,000 | 1 July 2023 |
| Late lodgement of an application for renewal of accreditation | \$13,814 | 1 November 2023 |
| Application for variation of conditions of accreditation | \$1,500 | 1 November 2023 |
| Application for approval of a project impact report | \$500 | 1 July 2023 |

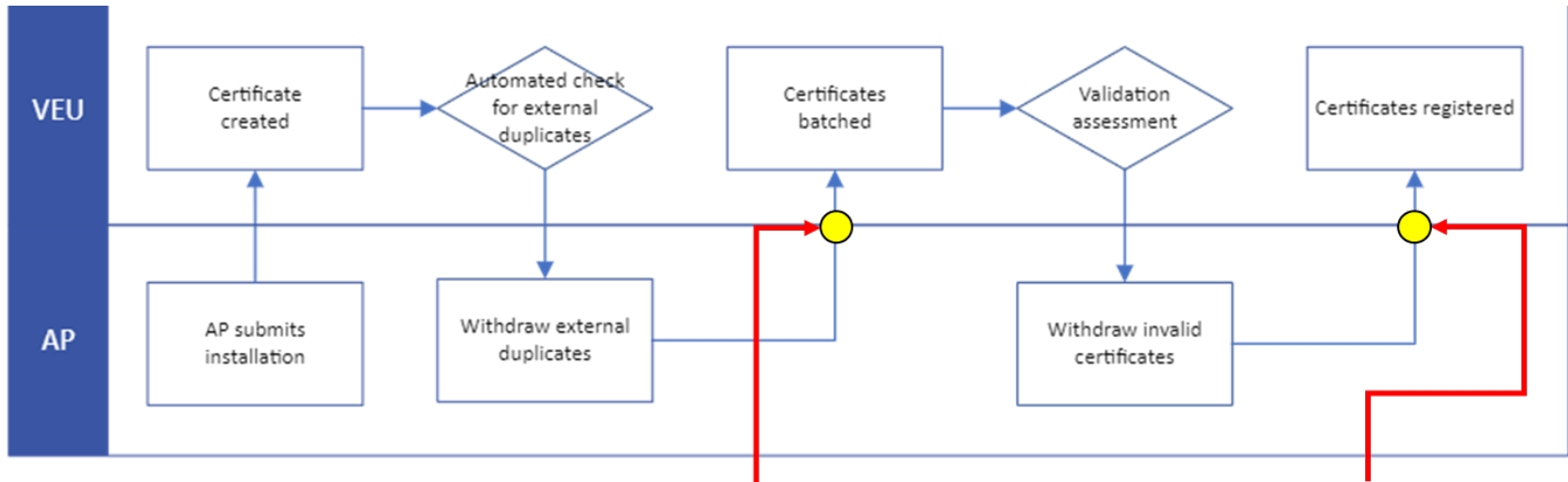
Summary of changes from 1 Nov 23

- Revised VEEC creation fee of \$2.33 per certificate, replacing the existing \$1.00 VEEC registration fee.
- The fee is payable at the point of VEEC creation and applies to all VEECs created, rather than only VEECs registered.
- VEEC creation invoices will be issued twice weekly on Tuesday and Thursday for VEECs created before the 6am invoicing deadline that day.
- VEEC creation fees will be waived when an accredited person withdraws an external duplicate through the online registry before the 6am invoicing deadline on Tuesdays and Thursdays.

VEEC creation fee process from 1 Nov 23

1. APs create certificates.
2. External duplicates are immediately returned to the AP, and the AP has an opportunity to withdraw certificates.
3. Every Tuesday and Thursday at 6am, the VEU system calculates and issues fees.
4. Any certificates that are not withdrawn by this time will be charged a fee.
5. Activities that have been charged a fee are updated to Pending payment and an invoice is created.
6. Once the fee is paid, Registry staff can follow their normal batch assessment and validation routine.

VEEC creation fee process from 1 Nov 23



From 1 Nov 2023 the VEEC creation fee is charged here. VEECs will not proceed to validation until the fee is paid.
